Breeder (Class C)	<p>Can</p> <p>Perform the following activities on greyhounds whether owned by self or other people (with consent from the Owner of the greyhound)</p> <ul style="list-style-type: none"> - Arrange for the service or artificial insemination of a female greyhound - Care for the pregnant female greyhound until up to 7 days before her expected whelping date - Make decisions regarding the female’s breeding and care. <p>Breed a maximum of 1 litter per Breeder per calendar year in total with appropriate authorisation from GRV (intention to breed, name two greyhounds, permission from GRV – more control of Category C than other categories)</p> <p>Cannot</p> <ul style="list-style-type: none"> - Perform activities under other categories unless registered to do so - Breed more than 1 litter per calendar year 	<p>means the owner of a bitch or person authorised pursuant to these Rules to use her for breeding purposes as at the date of whelping. (GAR proposed)</p> <p>Suggest: <i>means a person registered by the Board to care for a female greyhound from 7 days before her expected whelping date until her puppies are weaned off her; as well as her puppies from their birth until up to 20 weeks old</i></p>	<ol style="list-style-type: none"> 1. (GAR)</p> <p>Suggest: <i>(Keep)</i></p>	<ol style="list-style-type: none"> 1. Aged 15 years or older 2. Principal place of residence in Victoria 3. Completed prescribed education within time set by the Board 4. Be a fit and proper person
